However, the majority of your dues payment to the Wisconsin Cheese Makers Association is deductible as a necessary and ordinary business expense. A portion of your dues related to lobbying efforts by the Wisconsin Cheese Makers Association cannot be taken as a business expense deduction. Based on WCMA lobbying expenditures and dues income, our Association has estimated that 80 percent of your dues payment may be deducted by your firm as a business expense. The remaining 20 percent cannot be deducted, as this percent of the Association's expenditure of dues relates to lobbying activities.
